The Central Gulf Industrial Alliance (CGIA) is working to meet the current and future workforce needs of our members through the CGIA Endorsement Program. We would like to engage creative students and instructors from endorsed programs to design and build a sculpture to showcase the talent along the Central Gulf Coast.

The winning team will receive \$250 and the winner's school will receive an additional \$250 to cover materials (\$500 total prize money). The winners will also receive recognition on Central Gulf Industrial Alliance's website. All sculptures will be displayed at our General Membership Meeting on November 4th.



CONTEST RULES

- 1. ELIGIBILITY:** To be eligible to enter the Contest, applicants must either be teaching or enrolled in a program endorsed (or Emerging Partner) by Central Gulf Industrial Alliance (CGIA).
- 2. HOW TO ENTER:** To participate, please register your team by October 4, 2021, by emailing the following information to hbarlar@cgialliance.com : School name, Endorsed program, Instructor name, Student names.
 - a. LIMIT THREE (3) ENTRIES PER CGIA-ENDORSED PROGRAM**
 - b. An instructor must participate on the team and serve as the point of contact.**
- 3. CONTEST REQUIREMENTS:** The sculpture must meet the following criteria
 - a. The sculpture must incorporate a Gulf Coast or Industrial theme. For example: ships and other watercraft; local fishing, food or even football; birds and other Gulf Coast beasts. Use your imagination!**
 - b. The sculpture must be made out of industrial materials used in your craft – metals, plastics, fiberglass, wood, wire and electrical components (no capacitors, please). You can use original parts or modify them to fit your idea.**
 - c. The completed sculpture may not exceed 18" (L) x 18" (W) x 18" (H) in size.**
 - d. The sculpture must be free standing.**
 - e. CGIA reserves the right, in its sole discretion, to disqualify any Entrant who submits an inappropriate or offensive sculpture.**
 - f. The completed sculpture must be delivered to CGIA's Office by 3:00 p.m. on Thursday, October 21, 2021. Call or email Hayleigh Barlar to schedule the delivery.**
- 4. JUDGING:** Each sculpture will be voted on by attendees at the General Membership Meeting.
- 5. NOTIFICATION OF WINNERS:** Contest winners will be notified at the end of the meeting on November 4, 2021.
- 6. PRIZES:** The team that wins will receive \$250 and the school will receive an additional \$250 to cover materials (\$500 total prize money). The winning team will also receive recognition on Central Gulf Industrial Alliance's website.
 - a. In the event of a tie, total prize money will be split between the winning teams.**
 - b. CGIA will make arrangements to distribute the prize money to the winning team.**
